5. PRELIMINARY RESULTS FOR THE NEW DIGITAL CONTROLS FOR THE HEATING AND COOLING SYSTEM

The Secretary-Treasurer stated that since October when the new controls became fully operational, the foundation has saved nearly \$9,000 in electrical costs over the same time period for the previous year or approximately 21.6 percent. The Secretary-Treasurer stated that the annual savings for the new controls had been initially estimated at five percent. He stated that he will continue to keep the Board of Trustees informed about the reduction in the bar building's energy consumption.

President Methvin asked if there was any further business to come before the Board of Trustees. There being none, a motion was made and seconded to adjourn. The motion was approved.
