2008 GRANDE CONVOCATION AND ANNUAL BUSINESS MEETING

1. CALL TO ORDER

President Sam Crosby called to order the 129th Grande Convocation and Annual Business Meeting of the Alabama State Bar.

2. GRANDE CONVOCATION SPEAKER H. THOMAS WELLS, JR.

After making a few brief remarks, President Crosby introduced H. Thomas Wells, Jr., president-elect of the American Bar Association (ABA) for remarks. Mr. Wells' remarks concerned his plans during his term as president of the ABA which would commence at the ABA's annual meeting in August. He stated that the guiding principle of his presidency would be to stay focused on concerns of all lawyers which are the core values of the profession: access to justice; independence (of the bar and the judiciary); diversity and the rule of law. Mr. Wells stated these core values unite the legal profession and that he planned to focus on them particularly with this being a national election year and a new incoming presidential administration. With regard to elections, Mr. Wells highlighted election standards that are supported by the ABA and explained resources from the ABA that would allow lawyers to help promote fair and free elections across the nation.

Mr. Wells next discussed each of the four core values and described how access to justice, independence of the profession, diversity and the rule of law are important to the legal profession. He concluded by noting that as lawyers we must all work to support these core values.

Following his remarks, President Crosby presented Mr. Wells with the book, "Sweet Home Alabama".

3. HALL OF FAME SELECTION COMMITTEE REPORT

President Crosby recognized Mr. Sam Rumore who announced the 2008 Hall of Fame Inductees. They were John B. Scott, Vernon Z. Crawford, Edward M. Friend, Jr. and Elisha Woosley Peck.

4. <u>LOCAL BAR ACHIEVEMENT AWARD</u>

President Crosby recognized Ed Patterson for the presentation for the local bar achievement award. The award was presented in the large bar category, to the Mobile Bar Association with Ian Gaston, president, accepting. In the medium bar category, the award was presented to the Calhoun-Cleburne County Bar Association, Randy J. Moeller, president. Commissioner John Gruenewald accepted on behalf of Mr. Moeller.

9. <u>LEADERSHIP FORUM GRADUATES</u>

President Crosby then recognized the Leadership Forum graduates from Classes I-IV as a group and asked them to stand.

10. PRESIDENT'S CONCLUDING REMARKS

President Crosby recognized immediate past president Boots Gale. Mr. Gale first presented a framed certificate to Brenda Roland, President Crosby's secretary and thanked her for her service. Next, Mr. Gale made several remarks about Mr. Crosby's term as president and presented him with the past president's plaque and ribbon.

11. PRESENTATION OF THE CHIEF JUSTICE'S LEADERSHIP AWARD TO SAM CROSBY

Before returning to his seat, Mr. Gale recognized Chief Justice Sue Bell Cobb. Chief Justice Cobb presented President Crosby with the Chief Justice Leadership Award. Mr. Crosby thanked the Chief Justice for the recognition.

12. <u>CONCLUDING REMARKS OF PRESIDENT AND INTRODUCTION OF PRESIDENT-ELECT</u>

President Crosby made his concluding remarks as president of the Alabama State Bar. Following his remarks, he asked Mr. Tom Methvin to come to the podium. President Crosby congratulated Mr. Methvin on his election as president-elect. Mr. Methvin made brief remarks. At the conclusion of his remarks, Mr. Methvin presented Chief Justice Cobb with her very own navy blue blazer as a token of appreciation for her close work with the bar since her installation as chief justice.

13. <u>INTRODUCTION OF NEW PRESIDENT</u>

President Crosby introduced the state bar's new president, Mark White and called Mr. White to the podium. He turned over the office of president to Mr. White and presented him with the president's gavel and presidential ribbon. President White thanked Mr. Crosby. He introduced his wife, family members, law firm members and staff who were present as well as several close friends.

President White outlined his vision for his year as president which includes access to justice for the poor, indigent defense (a state-wide indigent defense commission), mentoring, professionalism and instilling pride in our profession. Prior to concluding his remarks, President White asked all those present to stand and re-take the Oath of Office which Chief Justice Cobb administered.

14. GRAND PRIZE DRAWING

President White recognized Laura Calloway and ISI president Bill Bass for the drawing of the 2008 Grand Prize provided by ISI Alabama. The grand prize was won by Bob Clute of Mobile.

15. ADJOURNMENT

President White closed by stating that the 2009 Annual Meeting would be at the Grand Hotel in Point Clear, July 15-18 and reminding the commissioners of a brief meeting in Emerald Ballroom A-B. He then declared the 2008 Grande Convocation and Annual Business Meeting of the Alabama State Bar adjourned.
