McLain Receives Alabama State Bar Professionalism Award

At this year's annual meeting in July, state bar General Counsel J. Anthony McLain received the Alabama State Bar Professionalism Award.

The award recognizes an attorney for his/her distinguished service in the ad-

vancement of professionalism. This year marks the inception of the award and it will be known as the J. Anthony "Tony" McLain Award.

McLain began his career with the Alabama State Bar in 1988 as assistant general counsel, and was named general counsel in 1995. In this role, McLain is responsible for overseeing the operations of the Center for Professional Responsibility, which investigates and prosecutes bar complaints, issues ethics opinions to lawyers, represents the bar in state and federal litigation and provides legal advice to the bar's governing body, the Board of Bar Commissioners.

Prior to his service to the bar, McLain served as an assistant attorney general during the administrations of Attorneys General Bill Baxley and Charlie Graddick. He later practiced law with the firm McLain & Hampton. He is a graduate of Auburn University and received his law degree from Samford University Cumberland School of Law.

Johnson Receives Bar Administrator of the Year Award

Recently-retired state bar Director of Admissions Dorothy Johnson received the Bar Administrator of the Year Award from the National Conference of Bar Examiners (NCBE) during the organization's annual

meeting in Minneapolis.

The Administrator of the Year Award recognizes exemplary service by a bar admissions administrator. Individuals who receive the award are leaders within the field of bar admissions and have often contributed years of service to the profession.

"Dorothy rendered outstanding service to the legal profession for more than 20 years, and, in that time, she touched the lives of so many people," said Alabama State Bar **President Rich Raleigh**. "Dorothy assisted thousands of Alabama bar applicants during her career with the Alabama State Bar, including people who have gone on to be leaders in their local communities and our nation. She approached every task with professionalism and grace. Dorothy has been an asset to our bar, and is most deserving of this honor."

The award recipient is selected each year by the current chair of the National Conference of Bar Examiners. This year's



Ice Bucket Challenge Goes Legal! Adams & Reese Participates in Ice Bucket Challenge

The popular and gone-viral "ALS Ice Bucket Challenge" continued in New Orleans recently as Adams & Reese's managing partner participated in the challenge on the steps of One Shell Square, and the firm made a \$1,000 donation to Team (Steve) Gleason and ALS (amyotrophic lateral sclerosis).

The challenge has raised over \$4 million globally to fight the neuromuscular disease.

The Ice Bucket Challenge has been performed by people across the nation, from Ethel Kennedy to Justin Timberlake, to several NFL teams, coaches and many media anchors and celebrities. In the last two weeks, the ALS Association and its 38 chapters have received \$4 million in donations compared to \$1.12

million during the same time last year. Since July 29, the association has welcomed more than 70,000 new donors to the cause.

On September 25, 2006, Steve Gleason was responsible for one of the most dramatic moments in Saints' history, when he blocked a punt in the first quarter against the Atlanta Falcons, which was recovered in the Falcons' end zone for a touchdown. It was the first score in the Saints' first home game in nearly 21 months, following Hurricane Katrina.

In January 2011, three years after his retirement, Gleason was diagnosed with ALS. He and his foundation are committed to helping those with ALS live productive, inspired lives by providing access to life-affirming events and assistive technology until a cure is found.

The ALS Association is one of the more than 200 organizations to which the Adams & Reese employee volunteer program, also known as HUGS (Hope, Understanding, Giving and Support), donates thousands of hours and dollars.

- Successfully achieved legislation or rule changes that contributed substantially to legal services to persons of limited means or low-income communities.

Don't Check Out of the Dues Check-Off!

The September dues statement presents bar members with the opportunity to make a \$50 tax-deductible contribution to the Alabama Law Foundation in the form of an opt-out dues check-off.

WHY WE NEED IT-Reduced Income

- IOLTA revenue is down from \$1.3 million six years ago to \$410,000 now.
- Grants to organizations providing legal services have gone from \$919,000 in 2010 to \$398,000 now.
- \$45 of every \$50 donated will be added to the foundation's funds available for legal aid grants.

WHY WE NEED IT-Increased Need

- Alabama has the seventh-highest poverty rate in America.
- Last year, Legal Services and four Volunteer Lawyer programs closed over 16,000 cases, yet **84 percent of civil** legal needs of low-income households went unmet.

A CLE for Those Who Deal with

Foreclosure And Servicer Regulations

Mediation Program Helps Everyone Win



The Family Mediation Program is a special mediation project, developed and administered by the Alabama Center for Dispute Resolution. The program was established because Alabama Supreme Court Chief Justice Roy Moore wanted families who were in divorce or child-support situations to have help available as they continued to parent and guide their children. Child specialists explain that continued fighting and conflict between parents is most detrimental to the health and well-being of children; working with a mediator to develop a parenting plan with parental responsibilities, support and child time to give to a judge during proceedings is essential to de-escalating conflict and helping children thrive after divorce.

The supreme court receives a small

amount of funding under Section 12-10A-4 Code of Alabama (1975) which provides for statewide coordination of pro bono services and furtherance of attorney professionalism. Because the center has a statewide network of trained family mediators, the court asked it to develop and provide free mediation to families with children who have limited means.

In the first phase, 20 families had mediation assistance in Dallas, Bibb, Perry, Wilcox, Houston and Shelby counties. In addition, mediators provided over 40 hours of additional non-paid pro bono time to those families.
