State of Florida v. Clemente Aguirre-Jarquin: The Long, Winding Path to Freedom

Speakers: Lindsey Boney and Dylan Black

Clemente Aguirre spent 14 years in prison—10 of them on death row—after being wrongfully incarcerated and convicted for the 2004 double-stabbing murders of two women who lived next door to him. His initial trial counsel never investigated his claim

of innocence, never hired forensic experts and never tested for DNA the 150+ items that police collected from the crime scene, but once that evidence was collected (after his conviction), another person's DNA was at the crime scene (and none of Aguirre's DNA was present) and that other person confessed to the crimes. After a Florida trial court denied Aguirre's motion for a new trial, the New York-based Innocence Project asked Bradley to handle his appeal. The Florida Supreme Court unanimously reversed, vacated his convictions and death sentence, and ordered a new trial. At Aguirre's request, Bradley stayed on to represent him in his new trial before the state ultimately dropped the charges in November 2018, after three weeks of jury selection and in-court depositions related to the new evidence.


