AL - SB153 Medical care, minors, requires doctors to obtain consent of parent or legal guardian of minor prior to entering "do not attempt resuscitation order" order, Sec. 22-8A-18 added; Sec. 22-8A-7 am'd.

AL - SB166 Financial institutions, authorized to refuse to execute or delay execution of certain financial transactions involving account of an elderly or vulnerable adult when financial exploitation may have occurred, may have been attempted, or is being attempted

AL - SB167 Elder abuse, require redaction of contract information from court documents released to the public, to clarify that an elderly person of sound mind or body may hire legal counsel for representation, Sec. 38-9F-6 am'd.
