

The Corporate Transparency Act (CTA), enacted in 2021, was created to help curtail financial impropriety and money laundering in the U.S. through the use of holding and shell companies. Under the CTA, roughly 25 million U.S. companies will be required to file beneficial ownership reports with the Financial Crimes Enforcement Network of the U.S. Treasury beginning on January 1, 2024. Failure to comply with the CTA's reporting requirements can lead to civil and criminal penalties for reporting companies and potential legal malpractice liability for lawyers failing to advise their clients on the new reporting requirements of the CTA. "Alabama's State Courts: A Model for the Nation" was one of the headlines in the May 12, 1975 edition of the Washington Post, not exactly an Alabama-friendly newspaper back then. The article was based on the passage of the Judicial Article in 1973 and the implementation legislation in 1975. The campaign was led by Alabama's Chief Justice Howell Heflin, the Alabama Citizens Conference on State Courts, and the Alabama State Bar. The culmination of these efforts resulted in the creation of a modern, unified statewide court system recognized as one of the oldest in the nation. In honor of the 50th anniversary of this event, it is only fitting that we recognize it by having a panel of individuals who were present at the creation to talk about how this monumental achievement was accomplished.

OH HOW I MISS COMMON LAW PLEADING! FIFTIETH ANNIVERSARY OF WHAT A FEW OF US ONCE CALLED "THE NEW RULES"

The Alabama Rules of Civil Procedure, adopted 50 years ago by the Supreme Court of Alabama, dramatically changed the practice of law in Alabama. When the Alabama Legislature vested rule-making power in the Supreme Court of Alabama, the Act proclaimed that the new rules should simplify practice and procedure in civil cases and secure "the just, speedy, and inexpensive determination of cases on their merits." This mandate is embodied in Rule 1(c) of the rules themselves. "These rules shall be construed to secure the just, speedy and inexpensive determination of every action." According to Oakley W. Melton, Jr., original chair of the Supreme Court Advisory Committee on the Rules, the policy of the rules is to disregard technicality and form in the order that the rights of litigants may be asserted and tried on the merits.

This panel includes two individuals who were in the thick of the adoption of these rules 50 years ago, Justice Champ Lyons, Jr., the reporter and one of the two surviving members of the original Supreme Court Advisory Committee on Rules of Civil Procedure and John Wilkerson, former clerk of the court of appeals who worked for Chief Justice Howell Heflin and was instrumental in the adoption of these rules. Bruce McKee, attorney with Hare Wynn who is considered the "unofficial historian" of the Alabama Rules of Civil Procedure Committee, will join them. The moderator will be Justice Greg Cook of the Supreme Court of Alabama, an acknowledged expert on the ARCP.
