The Judicial Inquiry Commission has considered your request for an advisory opinion regarding a judge's obligation to recuse himself from hearing a criminal case in which the defendant's aunt is the wife of the judge's wife's first cousin. The criminal case is a capital referral.

It is the opinion of the Commission that the judge is not disqualified from hearing a criminal case in which the defendant's aunt is the wife of the judge's wife's first cousin. Canon 3C(I)(d)(i).

Canon 3C(I)(d)(i) of the Canons of Judicial Ethics requires a judge to disqualify himself or herself from hearing a case in which "[h]e or his spouse, or a person within the fourth degree of relationship to either of them, or the spouse of such a person" is a party. The defendant is not within the fourth degree of relationship to the judge or the judge's wife, therefore the judge is not disqualified by the canons.
