LAW FOUNDATION AWARDS Justice Janie L. Shores Scholarship

The Alabama Law Foundation announces that **Amber Busby** has been awarded \$4,750 as the 2015 winner of the Justice Janie L. Shores Scholarship. As Allison Skinner, chair of the scholarship committee, explains, "In 2006, the Women's Section of the Alabama State Bar, along with the Alabama Law Foundation, established the Janie L. Shores Scholarship to support a female Alabama resident attending an Alabama law school." The scholarship is named in honor of the first female Alabama Supreme Court Justice, who was elected in 1974.

Busby graduated from the University of Alabama with a Bachelor of Arts and Sciences degree and a double major in Spanish and history. She was a member of the University Honors and International Honors College. Other notable achievements include being named an

Omega leadership honor society and Phi Alpha Theta history honor society. Busby has continuously worked to assist in financing her college and law school career and gained knowledge of government functions as a professional staff member on the United States Senate Committee on Appropriations and staff assistant for Alabama Senator Jeff Sessions. She has used her fluency in Spanish as an English tutor in Spain and as a Spanish tutor in Tuscaloosa and Washington, DC. Busby plans to continue working as a law clerk between law school terms.

With a passion for underserved women and children, Busby volunteers as a tutor and mentor, is a member of the Dorbin Association and has raised money for Turning Point of West Alabama. She has the unique honor of being the first scholarship recipient whose mother, **Ginger Busby**, is an attorney. Amber expressed her respect of women in law and her appreciation of the scholarship, "With my mother as an attorney, I am even more appreciative of women in the practice of law. I am honored to be the recipient of this prestigious scholarship that recognizes the contribution of women in the profession, particularly Justice Shores. I am so grateful for this financial assistance, and with it, I will do my best to make the members of this profession proud."

Busby was recognized at the Maude McLure Kelly Award luncheon held during the ASB annual meeting. The luncheon is named in honor of Alabama's first woman lawyer, who became the first woman lawyer in the United States to plead a case before the U.S. Supreme Court.

A silent auction, held the evening after the luncheon, raised money for the scholarship. ■

Magistrate Judge Chosen for Middle District

The judges of the United States District Court for the Middle District of Alabama announce the selection of **Gray M. Borden** to fill the United States Magistrate Judge vacancy created in the Middle District of Alabama due to the retirement of Hon. Charles S. Coody. A merit selection panel composed of attorneys and other members of the community reviewed all applicants for the position and submitted to the District Court the five names of those best qualified for the vacancy. After a full-field background report by the Federal Bureau of Investigation and the Internal Revenue Service, Borden will be appointed by the court to fill the vacancy.

Borden is an Assistant United States Attorney with the Middle District of Alabama. A native of Montgomery, he graduated with a B.S. degree from Washington and Lee University. He received his juris doctorate degree magna cum laude in 2005 from the University of Alabama School of Law, where he was editor in chief of the *Alabama Law Review* and

qualified scholastically for Order of the Coif. After law school, he clerked for United States District Judge William M. Acker, Jr. and was associated for several years with Lightfoot, Franklin & White of Birmingham before joining the U.S. Attorney's office in Montgomery.

Borden will serve an eight-year term, but can be reappointed. ■

ESIRT Presents E-Discovery Program

If you need to learn more about e-discovery but you don't know where to start, you'll want to attend the upcoming special presentation of "The Decade of Discovery," which will be followed by a panel discussion with some of Alabama's most knowledgeable attorneys and judges and will close with a cocktail reception. The program, hosted by Birmingham's ESI Roundtable, will take place Thursday, September 24, from 4:00 to 7:00 pm at the offices of Balch & Bingham, 1901 6th Ave. N, Birmingham. The program has been approved for 1.5 hours of MCLE credit by the Alabama State Bar.

"The Decade of Discovery" is an award-winning documentary about a government attorney on a quest to find a better way to search White House email and a teacher who took a stand


for civil justice on the electronic frontier. It chronicles events which took place in U.S. courts between 2002 and 2012, leading to revolutionary changes in the way that discovery of electronically-stored information is now conducted. The film focuses on the growth and evolution of the e-discovery industry and recounts the significant cases—and the jurists who had to wrestle with them—to forge current e-discovery practices.

"What I like about this documentary is that it tells the history of e-discovery from the point of view of the lawyers and judges involved since the inception of the challenge, which is now mainstream in litigation and practice," says Melissa Rogozinski, president of the ESI Roundtable.

The ESI Roundtable is a community-based organization with chapters in major

cities around the U.S. that brings together judges, lawyers and e-discovery professionals to help shape best practices in electronic discovery, as well as making continuing legal education available on the topic of e-discovery. Membership in the ESIRT is available and allows members to receive reduced-price MCLE programs, a litigation forms library and a presentations library. Rogozinski can also assist with referrals to the most appropriate e-discovery technologies and providers.

The Alabama Judicial Inquiry Commission recently selected **Billy C. Bedsole**, a partner in the Mobile firm of Stockman & Bedsole, as its chair. He is only the second attorney to serve as chair in the past 25 years.

Created by the Alabama Constitution, the Judicial Inquiry Commission enforces the *Alabama Canons of Judicial Ethics*, the ethical rules that govern Alabama state judges. Its jurisdiction includes consideration of sworn complaints concerning any state judge's alleged violation of the *Canons*, misconduct in office, failure to perform judicial duties or inability to perform judicial duties because of a physical or mental disability. The commission also prosecutes any formal charges it has filed in the Alabama Court of the Judiciary. In addition, the Alabama Supreme Court has authorized the commission to render advice to judges regarding their duties under the *Canons*.

Bedsole, a member of the Alabama State Bar for 52 years, was one of two appointments by the state bar to the commission in 2011. He has also served the state bar and the Mobile Bar Association in numerous positions.

Rich award in honor of Susan Elliot Rich, who was the firm's first woman shareholder, the first woman to be appointed as an office managing shareholder and the first woman appointed to the board of directors. This award is given annually to a recipient who exemplifies ongoing commitment and effort to strengthen the role of women attorneys at Baker Donelson.


H. Jerome Thompson
